Diego Acosta

Dr Diego Acosta is a leading international expert on International, European and comparative Migration law and a Professor of European and Migration Law at the University of Bristol in the UK. He is also the International Strategic Lead at the Migration Mobilities Research Centre at the same University. His work discusses Migration law as a central aspect of globalisation and analyses various processes of inclusion and exclusion and their profound implications for the rule of law in Europe, South America and other regions. He is the author of more than 60 publications, and his latest monograph is The National versus the Foreigner in South America. 200 Years of Migration and Citizenship Law (Cambridge University Press, 2018). His new project analyses free movement of people regimes and has obtained external funding to map these regimes globally. Dr Acosta is regularly invited to present his work at some of the most prestigious universities around the globe and has been visiting fellow at several institutions, including the University of New York (NYU), the European University Institute (EUI) in Florence, the Institute for Human Sciences (IWM) in Vienna, the Centre for Migration Studies at Toronto Metropolitan University, or the Centre for Fundamental Rights at Hertie School in Berlin. He has testified on migration law reform before Parliaments in Chile, Colombia, Ecuador, and Peru. He has provided consultancy for various governments, international organisations, law firms, political parties and NGOs in the USA, Europe, Latin America, the Caribbean and Africa. He has been interviewed by media outlets in the USA, UK, Spain, Russia, Denmark, Brazil or Ecuador

Since 2009, he has been affiliated with the FXB Center for Health and Human Rights at Harvard University, where his research has contributed to advocacy on behalf of vulnerable populations affected by disasters and humanitarian crises. His interdisciplinary interests in mobile technology, disaster response, and population health have been informed by his clinical practice in the United States and his field work around the world. His research has resulted in innovative applications of mobile, cloud-based technology to address public health challenges in mass gatherings, disasters, and humanitarian crises. At Harvard, he directs the Indian Digital Health Network, at the Lakshmi Mittal and Family South Asia Institute, a policy-research group whose products have shaped the digital health information architecture in India. He co-directs CrisisReady.io, an interdisciplinary research-response network hosted at Harvard and Direct Relief, that promotes data-driven analysis to policy makers responding to disasters and public health emergencies. He is director of the Climate and Human Health fellowship cohosted by the BIDMC Department of Emergency Medicine, the Center for Climate, Health and Global Environment at Harvard Chan, and the FXB Center.

Anikó Bakonyi

Anikó Bakonyi is a human rights defender from Budapest, Hungary. For the past twelve years, she has been working for the Hungarian Helsinki Committee, the leading Hungarian NGO focused on refugee rights, where she is now Head of the Refugee Program. Her work focuses on protecting the rights of refugees through human rights monitoring, counselling, advocacy, and reporting. In her professional life, Anikó has worked with victims of human trafficking, Roma and Jewish Holocaust survivors and their families, and refugees arriving in Hungary from all over the world. Since 2020, she also serves as one of the co-chairs on the board of the Berlinbased EU-Russia Civil Society Forum, with a membership of 180 organizations from the EU and Russia. Her interests have always centered around social justice, and protecting and empowering disadvantaged groups in society.



Jacqueline Bhabha

Jacqueline Bhabha is a Professor of the Practice of Health and Human Rights at the Harvard T.H.Chan School of Public Health, the Jeremiah Smith Jr. Lecturer in Law at Harvard Law School, and an Adjunct Lecturer in Public Policy at the Harvard Kennedy School. She is also the Director of Research at the FXB Center for Health and Human Rights at Harvard University. She received a first class honors degree and an M.Sc. from Oxford University, and a J.D. from the College of Law in London. From 1997 to 2001, Bhabha directed the Human Rights Program at the University of Chicago. Prior to 1997, she was a practicing human rights lawyer in London and at the European Court of Human Rights in Strasbourg. She has published extensively on issues of transnational child migration, refugee protection, children's rights and citizenship. She is the author of Child Migration and Human Rights in a Global Age (2014) and Can We Solve the Migration Crisis? (2018). She has edited or co-edited many books, including Children Without A State (2011), Human Rights and Adolescence (2014), Research Handbook on Child Migration (2018), A Better Future: The Role of Education for Displaced and Marginalized People (2020), and A Time for *Reparation: Addressing State Responsibility for Collective Injustice* (2021).

Vasileia Digidiki

Dr Vasileia Digidiki is a Harvard Instructor, the Director of the Harvard FXB Summer Program on Migration and Refugee Studies, and a Health and Human Rights Fellow. She is a psychologist by training with more than 14 years of experience working on issues of distress migration, human trafficking, victim blaming and child protection and serves as a Senior Associate Editor for the Behavioral Medicine, a Taylor and Francis Publications journal with an impact factor of 2.4.

Since 2017, Dr. Digidiki has led the Harvard FXB Center's research agenda on distress migration. She has conducted research in Greece, Bangladesh, West and Central Africa, Sudan and Mexico focusing on child protection, access to education, access to antenatal care, and the nexus between human trafficking and distress migration. Dr. Digidiki has been funded by a number of international organizations, including IOM, BRAC and UNICEF, to analyze datasets and conduct research in the field of migration, child protection and human trafficking. In 2021, she was commissioned by IOM to produce the first worldwide report on child trafficking, analyzing the largest worldwide dataset on child trafficking victims.

In 2022, Dr. Digidiki and Prof. Jacqueline Bhabha, developed the first international, interdisciplinary summer program on migration and refugee studies in collaboration with the National and Kapodistrian University of Athens. Dr. Digidiki also teaches in the FXB Center's Executive Education program for child protection professionals, as well as the Center's Child Protection Certificate Program for students, and has taught for Harvard University's Harvard X online training on Child Protection. Dr. Digidiki holds a Bachelor of Arts in Psychology, two master's degrees on Forensic and Social Psychology and a PhD in Social and Clinical Psychology. During her PhD studies, she was awarded the Greek State Scholarship, and in 2019 she was awarded the Health and Human rights Fellowship. She is a native of the Greek island of Lesvos where she offered her services as a first responder during the massive influx of distress migrants in 2015 and 2016.

Emmanuella Doussis

Emmanuella Doussis is a professor of international institutions at the National and Kapodistrian University of Athens, director of the Institute of European Integration and Policy and UNESCO Chairholder on Climate Diplomacy. She lectures on international institutions, international and European environmental law and policies, the role of international law in addressing several crises, including the climate crisis, climate diplomacy & climate policies with a focus on Southeast Europe. She has studied political science and law at the University of Athens and at the Sorbonne in Paris (Paris I). Her interest in environmental issues goes back to when she was a student in Paris. After a first Master in International Law, she completed a second one in Environmental Law. Since then, environmental issues have been at the center of her research interests.

She has been a Fulbright Visiting Scholar at UC Berkeley, visiting professor at the Universities of Grenoble-Alpes, Bourgogne, Aix-Marseille and a visiting fellow at the European University Institute (EUI). Her most recent book concerns the role of international law in effectively managing climate change (*International Law and Climate Change Diplomacy*, Nomiki Vivliothiki, Athens, 2020). She has coordinated European educational and research projects (Jean Monnet module on *Moving the EU forward* 2015-2018, Jean Monnet module on *European Climate Diplo*macy 2019-2022). She is a member of the IUCN World Environmental Law Committee, of the Scientific Council of the Centre for Mediterranean Integration, the scientific committee of the Hellenic Ministry of Foreign Affairs, the Greek National Committee for Adaptation on Climate Change.

She has published alone or in collaboration with other authors ten books, and many articles in peer-review international journals. For her educational and research activities she has been awarded the 2021 Natural Resources International Legal Specialist Award from the Centre of International Sustainable Development Law.

Monica is a barrister at the Bar of England and Wales, a specialist in public international law and international arbitration. A generalist in the field, she practices fromTwenty Essex, a leading barristers' chambers in London. Monica's practice n public international law is substantial and covers the full spectrum of She appears as counsel in English courts and in international areas. courts and tribunals. Monica is considered to be one of the preeminent experts in climate change and environmental litigation worldwide, including in law of the sea. She has advised Sovereign States on the feasibility of an Advisory Opinion on climate change before the ICJ and ITLOS. Notably, she acted for WWF in its amicus submissions in Request for an Advisory Opinion on Climate Change and International Law before ITLOS. Monica also acted in the first climate change contentious case before the UN Human Rights Committee, the Torres Strait Islanders case, securing a landmark decision protecting the rights of peoples in low-lying islands. She was also adviser to a State Party representative of a Least Developed Country in the drafting of the Rules of Procedure of Compliance with the Paris Agreement. Monica's work was featured in the documentary series Earthrise, 'Planetary Justice' by Al Jazeera, broadcasted in 2022 and 2023. She holds an LLM (LSE) and the Diploma of the Hague Academy of International Law. She has been a Visiting Fellow at Jesus College, University of Cambridge.

Maria Gavouneli is a Professor of International Law, Faculty of Law and Athens Public International Law Center – Athens PIL, National & Kapodistrian University of Athens. She also serves as Director, Refugee & Migration Studies Hub – RMS Hub, National & Kapodistrian University of Athens and presides at the Greek National Commission of Human Rights (2019-2022). Professor Gavouneli has also coordinated and taken part in major research teams funded by European and Greek resources, having received multiple research grants. She has also been a Fulbright Visiting Scholar 2018-2019 at the University of California Berkeley and a Visiting professor and lecturer in several universities and research institutions in Greece and abroad, including the Royal Institute of International Affairs (Chatham House), Tulane University (USA), the University of Edinburgh (Brodies Lecture), the University of Oxford, the University of Glasgow, the University of Manchester, Utrecht University.

Noora Lori is an Assistant Professor of International Relations at the Pardee School of Global Studies, Boston University. Her research focuses on citizenship, migration and racial politics in the Middle East and in comparative perspective. Her book, Offshore Citizens: Permanent "Temporary" Status in the Gulf (Cambridge University Press 2019) received the best book prize from the Migration and Citizenship section of the American Political Science Association (2020), the Distinguished Book Award from the Ethnicity, Nationalism, and Migration Studies section of the International Studies Association (2021), the Best Book in from the Middle East and North Africa politics section of the American Political Science Association. She has published in the International Migration Review, International Journal of Middle East Studies, Journal of Global Security Studies, Ethnic and Racial Studies, International Relations, the Oxford Handbook on Citizenship, The Shifting Border, among other journals and edited volumes. Her work has been funded by the ACLS/Mellon foundation, Ziet-Stiftung Ebelin und Gerd Bucerius, the Hariri Institute for Computing and Computer Engineering (BU), the Initiative on Cities (BU) (2016; 2019), as well as other grants. She is the co-director (with Kaija Schilde) of the Pardee School Initiative on Forced Migration and Human Trafficking. She is a Member (Chair) of the European Commission against Racism and Intolerance (ECRI). She also holds the Jean Monnet Chair on EU Solidarity Civil Protection and Humanitarian Action (July 2016). Marouda was a member of the Greek Delegation in the United Nations Preparatory Commission for the adoption of the International Criminal Law Statute, 2000-2002.



Margareta Matache

Dr. Margareta (Magda) Matache is a Lecturer on Social and Behavioral Sciences at the Department of Social and Behavioral Sciences, Harvard T.H. Chan School of Public Health, and the co-founder and Director of the Roma Program at the FXB Center for Health and Human Rights, Harvard University. She is also a member of the Lancet Commission on Reparations and Redistribute Justice and the O'Neill-Lancet Commission on Racism, Structural Discrimination and Global Health. Dr. Matache's research focuses on the manifestations and impacts of racism and other systems of oppression in different geographical and political contexts. Her research examines discrimination, reparations, social determinants of health-including education and social and economic disparities—and their nexus with the historical past and contemporary public policies, with a particular focus on anti-Roma racism. With more than 20 years of experience in activism and research, Dr. Matache has dedicated her work to advancing justice and Roma rights. Dr. Matache earned a BA in social work, an MA in European social policies, and a PhD in political science, all from the University of Bucharest, Romania and an MPA from the Harvard Kennedy School. From 2005 to 2012, Dr. Matache was the Executive Director of Romani CRISS, a human rights organization that defends the rights of Roma people. 

The AIRE Centre (Advice on Individual Rights in Europe) is a specialist legal charity based in London but our mandate is pan European. The AIRE Centre litigates before the European Court of Human Rights and the **European Court Of Justice** and has been involved in <u>over 100 cases</u> since the organisation was founded in 1993. Our policy has always been to offer our litigation expertise in whatever form it is needed, which may mean acting as representatives on the record, sharing our expertise on procedural and substantive law, or intervening as an expert third party in cases which we are not assisting in the representation.

Mission

We use the power of European law to protect fundamental rights. We do this by:

1. providing expert advice on European law,

2. conducting litigation in cases where fundamental European rights are at stake,

3. undertaking policy work, training and technical assistance to promote standard setting and the sound development of the law, and

4. operating a well-resourced and purposeful organisation for the benefit of those seeking to enjoy their fundamental European rights.

Impact

Where we identify critical human rights violations or gaps in policy or law which affect individuals in Europe, we step in and pursue cases with strategic potential. Impact

The GCR:

- Has an efficient team of interpreters, who act as intercultural mediators, documents and assesses the needs of refugees who arrive in their offices daily;
- Has a legal team of more than 70 lawyers that provides a wide range of legal services to refugees and asylum seekers;
- Their psychosocial support unit and their social services include individualized and multidisciplinary assistance that considers all the material and psychological needs of the beneficiaries of international protection, including assistance in family and medical emergencies, management of vulnerable cases, access to food and housing, referrals to state services and organization.

The Greek Council for Refugees (GCR) is a Non- Governmental Organization, which has been active since 1989 in the field of asylum and human rights in Greece. GCR is an association recognized as a special charity, is included in the Registers of competent Ministries, has Consultative Status in the Economic and Social Council (ECOSOC) of the UN since 2001 and is an operative partner of the UN High Commissioner for Refugees (UNHCR). In addition to the above, GCR is a member of the Executive Committee of the European Council on Refugees and Exiles (ECRE) since 1991, a member of the Separated Children in Europe Program (SCEP) while it also participates in the National Committee for Human Rights (EEDA) since 1999.

Mission

The GCR welcomes and offers free legal and social advice and services to refugees and people coming from third countries who are entitled to international protection in our country, while special emphasis is put on vulnerable cases, such as unaccompanied minors, victims of trafficking etc. The ultimate goal is their protection and their smooth integration in our country.

Impact (Continue)

The GCR's intercultural center PYXIDA hosts several cultural and educational activities which are addressed to recognized refugees, such as free Greek and English lessons, educational counseling and learning support, specialized workshops for children and adults, etc.

GCR's services are offered in Athens, Thessaloniki and in the region of Evros but also in Lesvos, Kos and Herakleion - Crete. The main sources of GCR stem from European and co-financed Programs, by the UN High Commissioner for Refugees, by grant making trusts as well as companies and individuals.

Impact

The primary goals of HIAS's work in Greece are twofold;

a) the provision of high quality legal support and representation to refugees with a focus on those who are most vulnerable, such as children and survivors of torture or genderbased violence (GBV) and the provision of psychosocial support to those in need.

b)HIAS' community-based mental health programs promote the well-being of individuals, families, and communities affected by crisis and conflict so they can heal and rebuild their lives. In 2022, 801 people received services. The Eastern Mediterranean route from Turkey to Greece's eastern borders is one of the most widely traveled refugee pathways in the world. Refugees, asylum seekers, and migrants from the Middle East, Africa, and Asia travel to Greece via sea and land, seeking safety in Europe.

Since 2014, more than 1 million people have crossed into the country, fleeing violence and humanitarian crises in Syria, Iraq, Afghanistan, and other countries. With this large influx of refugees, access to basic needs is scarce and vulnerable people are not sufficiently protected. Greece hosts about 121,000 refugees and migrants, 40 percent of whom are under the age of 18.

HIAS is the world's oldest refugee agency. Though the organization was formally established as the Hebrew Immigrant Aid Society in 1902, that founding moment represented a continuation of several predecessor organizations that had worked through the 1880s and 1890s to assist Jews fleeing pogroms in Russia and Eastern Europe. While those arriving in the United States at that time were refugees, the world did not yet have a legal concept for people who needed safe refuge outside their homelands.

Originally set up by Jews to help fellow Jews for reasons of religious imperative and communal solidarity, HIAS in the 2020s is a multicontinent, multi-pronged humanitarian aid and advocacy organization with thousands of employees dedicated to helping forcibly displaced persons around the world in keeping with the organization's Jewish roots. was, is and will always be at the frontline of emergencies.

Impact

THP currently operates 13 shelters in Athens, overseen by the Child Protection Unit. THP has supported over 1,000 children since 2016, successfully reuniting 225 of them with their families throughout Europe and has created 220 jobs. Notably, THP employs 25 individuals who were formerly beneficiaries of its shelters, serving as caregivers, interpreters, and cleaners.

Education holds a crucial position in THP's approach, as all children under their care attend Greek schools. The organization has formed partnerships with three renowned private educational institutions, which have played a vital role by offering scholarships enabling children to pursue higher education at the college and university level in Greece and in the US.

In Greece, care for unaccompanied refugee children remains scattered among NGOs and international bodies. Available European Union funds for accommodation and social welfare services remain under-utilized. The Greek state needs to develop the requisite capacity to properly protect and integrate refugee children who arrive alone. Chronic institutional incompetence contributes to social discontent and fatigue with refugee issues, giving ground to xenophobia and racism in public discourse and politics. There are 2,219 unaccompanied children in Greece today. A large number of them are excluded from institutional child protection services, without access to basic care, social welfare, or any information about their rights.

<u>Mission</u>

The HOME Project (THP) is a nonprofit organization created in 2016 to care for unaccompanied children whose families and lives are wrecked by war and persecution, empowering them to persevere and grow into active citizens.

What we do

We aim to improve the lives of unaccompanied minors by influencing child protection policy at a national and international level. Our goal is to influence society as a whole by guiding refugee children to become active citizens and encouraging local communities to welcome them.

At the heart of the organization is the THP child protection model, which provides:

- 1. A holistic network of child protection services guided by an Individual Development Plan addressing each child's particular needs over time, including physical and mental health, education, life skills, social and legal support
- 2.Employment for Greeks, migrants and refugees, including children reaching adulthood
- 3.A healing and inclusive environment, and active engagement of the local community in order to cultivate social inclusion

We are a member of the INTERSOS family which has been active since 1992 and is operating in more than 23 countries around the world.

<u>Mission</u>

Médecins du Monde / Doctors of the World is an international Non – Governmental, independent, humanitarian organization, which was founded in 1980 by 15 French doctors that believed in bearing witness and providing direct access to medical care for the world's most vulnerable populations.

<u>Mission</u>

The first and foremost mission of Médecins du Monde is to provide treatment. Actions though are not limited to medical care. Always based on its medical experience and acting independently, MdM is vocal against the obstruction of access to healthcare and the violation of human rights and dignity. Firm supporters of human rights, they are against racism, xenophobia and the social isolation and marginalization of social groups.

Impact

The MdM operate two polyclinics in Athens and Thessaloniki.

a) The operation of the **Social Dental Clinic** fills a significant gap by providing not only the necessary dental care to vulnerable children and adults but also systematic information and education aimed at adopting behavioral patterns and habits that lead to the improvement of oral health.

b) A Mobile Medical Unit, staffed by experienced health professionals, provides specialised care in paediatric, cardiology, gynaecology and general preventive check-ups for people living in remote and inaccessible areas. In the same context, another Mobile Medical Unit provides preventive dental, paediatric and ophthalmological health services to vulnerable populations.

It also runs an open migrant accommodation center with a capacity of 44 places that operates on a 24/7 basis.

MdM also operate within reception facilities of Lesvos in order to meet the needs of third-country nationals, with emphasis on sexual and reproductive health, women and children's health care, health education and health promotion. At the same time, it takes on awareness-raising activities regarding public health to local educational and social structures in Lesvos.

Impact

MSF is currently active in several locations across Greece:

In **downtown Athens**, MSF runs an Urban Day Care Center and a Clinic to respond to the medical needs of asylum seekers/migrants residing all around the city.

The Victoria Square Clinic provides primary healthcare and mental healthcare during afternoon and evening hours. Moreover, at a third center MSF and partner organization provide medical and mental healthcare to **survivors of torture and violence**. Médecins Sans Frontières (MSF) was founded in 1971 in France by a group of doctors and journalists in the wake of war and famine in Biafra, Nigeria. Their aim was to establish an independent organisation that focuses on delivering emergency medicine aid quickly, effectively and impartially.

<u>Mission</u>

We provide medical assistance to people affected by conflict, epidemics, disasters, or exclusion from healthcare. Our teams are made up of tens of thousands of health professionals, logistic and administrative staff - bound together by our charter. Our actions are guided by medical ethics and the principles of impartiality, independence and neutrality. MSF was created in the belief that all people should have access to healthcare regardless of gender, race, religion, creed or political affiliation, and that people's medical needs outweigh respect for national boundaries.

Impact (Continue)

In the **Elliniko** camps MSF teams provide sexual and reproductive healthcare, mental healthcare, distribute hygiene kits, and conduct health promotion activities.

In the camp of **Thermopyles** MSF provides mental healthcare and sexual and reproductive healthcare.

In **Lesvos**, MSF runs a Clinic in the town of Mytilini for all asylum seekers and migrants residing on the island.

In the camps of **Malakasa, Lavrio and Ritsona** MSF provides mental healthcare to migrants and asylum seekers

Impact

The Prolepsis institute aims to:

• be involved in the organization and implementation of Preventive Medicine and Public Health programs;

• design and implement educational actions for the general population and specific groups of the population;

• advocate and raise awareness on issues that threaten citizens' physical and mental health and perpetuate or exacerbate social inequalities;

• respond to the needs of the people that belong to each vulnerable group by alleviating human pain, and to provide support in cases of a crisis situation or a natural disaster; Prolepsis Institute is a civil non for profit organization established in 1990 in Athens, Greece, comprising a multi-disciplinary experienced team of physicians, health promotion and communication specialists, nutritionists, statisticians, psychologists, sociologists and economists. With a strong belief in health being a fundamental right, Prolepsis Institute has a leading role in the field of public health, by designing and implementing initiatives on several health issues in various sectors, targeting a wide range of groups, such as children, adults, women, migrants, Roma people, the elderly, and different types of occupational groups, such as health professionals, teachers, and educators as well as policymakers, other NGOs and decision makers

As a coordinator or a partner, Prolepsis Institute has participated in multiple large scale EU co-funded and national projects implementing research, educational initiatives, aiming at health promotion and education of the public, policy change and tackling health inequalities. Moreover, the Institute encourages interdisciplinary and international co-operation, creating networks of collaboration not only in Greece but also in Europe, and the USA. Prolepsis Institute has recently implemented a number of humanitarian focused projects aiming to promote the health and well-being of the vulnerable population groups.

Impact (Continue)

• Undertake research covering all project stages, including study design, protocol development, questionnaire or other measurement tools development, data collection, development of statistical methodology, data analysis, drafting of deliverables and related scientific publications.;

• Assess the impact of applied programs and actions by using scientifically documented assessment tools.

Direct beneficiaries in the last decade (since 2012) reach over 270.000 people. These people include children/teachers from low socioeconomic backgrounds, elderly people, migrants/refugees with specific focus on women, Roma people, health and other professionals, people suffering from natural disasters etc.

Advocacy, Street lawyering
