Sawsan Abdulrahim (PhD, MPH) is Professor of Public Health in the Faculty of Health Sciences at the American University of Beirut, Lebanon, and a Visiting Fellow at the Harvard FXB Center for Health and Human Rights (AY 2023-2024). In her research, she utilizes mixed methods to illuminate social inequities in health across the life course, with a focus on the wellbeing of refugees and labor migrants in the Arab region. Most recently, she served as PI of community-engaged studies on the wellbeing of Syrian refugee adolescent girls and migrant women care workers in Lebanon. Her research interests include (forced) migration and health; aging and care; and the impact of structural violence on the health of refugees. She teaches courses on research methods, health promotion theory, social epidemiology, and forced migration.

Dr Diego Acosta is a leading international expert on International, European and comparative Migration law and a Professor of European and Migration Law at the University of Bristol in the UK. He is also the International Strategic Lead at the Migration Mobilities Research Centre at the same University and the Director of the Nebrija-Santander Global Chair on Migration and Human Rights at Nebrija University in Madrid. His work discusses Migration law as a central aspect of globalisation and analyses various processes of inclusion and exclusion and their profound implications for the rule of law in Europe, South America and other regions. He is the author of more than 60 publications, and his latest monograph is The National versus the Foreigner in South America. 200 Years of Migration and Citizenship Law (Cambridge University Press, 2018). His new project analyses free movement of people regimes and has obtained external funding to map these regimes globally. Dr Acosta is regularly invited to present his work at some of the most prestigious universities around the globe and has been visiting fellow at several institutions, including the University of New York (NYU), the European University Institute (EUI) in Florence, the Institute for Human Sciences (IWM) in Vienna, the Centre for Migration Studies at Toronto Metropolitan University, or the Centre for Fundamental Rights at Hertie School in Berlin. He has testified on migration law reform before Parliaments in Chile, Colombia, Ecuador, and Peru. He has provided consultancy for various governments, international organisations, law firms, political parties and NGOs in the USA, Europe, Latin America, the Caribbean and Africa.

Jacqueline Bhabha is a Professor of the Practice of Health and Human Rights at the Harvard T.H.Chan School of Public Health, the Jeremiah Smith Jr. Lecturer in Law at Harvard Law School, and an Adjunct Lecturer in Public Policy at the Harvard Kennedy School. She is also the Director of Research at the FXB Center for Health and Human Rights at Harvard University. She received a first class honors degree and an M.Sc. from Oxford University, and a J.D. from the College of Law in London. From 1997 to 2001, Bhabha directed the Human Rights Program at the University of Chicago. Prior to 1997, she was a practicing human rights lawyer in London and at the European Court of Human Rights in Strasbourg. She has published extensively on issues of transnational child migration, refugee protection, children's rights and citizenship. She is the author of Child Migration and Human Rights in a Global Age (2014) and Can We Solve the Migration Crisis?(2018). She has edited or co-edited many books, Without A State (2011), Human including Children Rights and Adolescence (2014), Research Handbook on Child Migration (2018), A Better Future: The Role of Education for Displaced and Marginalized People (2020), and A Time for Reparation: Addressing State Responsibility for Collective Injustice (2021).

I am a seasoned journalist with over 20 years of experience working for print, broadcast, and online media, ranging from local radio stations and newspapers to global outlets Spiegel BBC. such and the as Der My work includes producing articles, covering stories including breaking news, writing features, analyses and op-eds, producing multimedia content, taking part in crossborder, award-winning investigative reporting (IJ4EU Impact Award 2022, 2023, De Tegel award 2022, European Parliament journalism award for 2009). In the past 8 years I have focused on investigative and human rights reporting with a focus on migration. I have intimate knowledge of policies, policy making and decision makers at a local (Greek) and EU level, have taken part in numerous conventions, seminars, and workshops (both as an attendant and as a speaker), closed briefings and field visits. I have extensive experience in public speaking and presentations on human and civil rights issues. Amal is a co-founder and one of the Co-Directors of the Institute. He is a Sri Lankan human rights lawyer, advocate and activist, with expertise in the right to nationality, statelessness and discrimination. Amal has researched, advocated, written, spoken, delivered training and served as an expert on statelessness and related issues for the UN, NGOs and academia, since 2008. Based out of ISI's London office, Amal has particularly focused on developing ISI's movement building, discrimination and advocacy work. Amal believes in the power of the arts to shape and inform our understanding and response to issues of social justice. He spearheads ISI's engagement with the arts and has (co) authored children's books and graphic novels to bring the challenge of statelessness to new audiences. Before co-founding the Institute, Amal led the statelessness work of the Equal Rights Trust. He was also a co-founder of the European Network on Statelessness, and a founding member of Stages - a Sri Lankan theatre group. A member of the Sri Lankan Bar, Amal holds an LLM (Distinction) from University College London and an LLB (Hons.) from the University of Colombo.

Vasileia Digidiki

Dr Vasileia Digidiki is a Harvard Instructor, the Director of the Harvard FXB Summer Program on Migration and Refugee Studies, and a Health and Human Rights Fellow. She is a psychologist by training with more than 14 years of experience working on issues of distress migration, human trafficking, victim blaming and child protection and serves as a Senior Associate Editor for the Behavioral Medicine, a Taylor and Francis Publications journal with an impact factor of 2.4. Since 2017, Dr. Digidiki has led the Harvard FXB Center's research agenda on distress migration. She has conducted research in Greece, Bangladesh, West and Central Africa, Sudan and Mexico focusing on child protection, access to education, access to antenatal care, and the nexus between human trafficking and distress migration. Dr. Digidiki has been funded by a number of international organizations, including IOM, BRAC and UNICEF, to analyze datasets and conduct research in the field of migration, child protection and human trafficking. In 2021, she was commissioned by IOM to produce the first worldwide report on child trafficking, analyzing the largest worldwide dataset on child trafficking victims.

In 2022, Dr. Digidiki and Prof. Jacqueline Bhabha, developed the first international, interdisciplinary summer program on migration and refugee studies in collaboration with the National and Kapodistrian University of Athens. Dr. Digidiki also teaches in the FXB Center's Executive Education program for child protection professionals, as well as the Center's Child Protection Certificate Program for students, and has taught for Harvard University's Harvard X online training on Child Protection. Dr. Digidiki holds a Bachelor of Arts in Psychology, two master's degrees on Forensic and Social Psychology and a PhD in Social and Clinical Psychology. During her PhD studies, she was awarded the Greek State Scholarship, and in 2019 she was awarded the Health and Human rights Fellowship. She is a native of the Greek island of Lesvos where she offered her services as a first responder during the massive influx of distress migrants in 2015 and 2016.

Emmanuella Doussis is a professor of international institutions at the National and Kapodistrian University of Athens, director of the Institute of European Integration and Policy and UNESCO Chairholder on Climate Diplomacy. She lectures on international institutions, international and European environmental law and policies, the role of international law in addressing several crises, including the climate crisis, climate diplomacy & climate policies with a focus on Southeast Europe. She has studied political science and law at the University of Athens and at the Sorbonne in Paris (Paris I). Her interest in environmental issues goes back to when she was a student in Paris. After a first Master in International Law, she completed a second one in Environmental Law. Since then, environmental issues have been at the center of her research interests.

She has been a Fulbright Visiting Scholar at UC Berkeley, visiting professor at the Universities of Grenoble-Alpes, Bourgogne, Aix-Marseille and a visiting fellow at the European University Institute (EUI). Her most recent book concerns the role of international law in effectively managing climate change (*International Law and Climate Change Diplomacy*, Nomiki Vivliothiki, Athens, 2020). She has coordinated European educational and research projects (Jean Monnet module on *Moving the EU forward* 2015-2018, Jean Monnet module on *European Climate Diplo*macy 2019-2022). She is a member of the IUCN World Environmental Law Committee, of the Scientific Council of the Centre for Mediterranean Integration, the scientific committee of the Hellenic Ministry of Foreign Affairs, the Greek National Committee for Adaptation on Climate Change.

She has published alone or in collaboration with other authors ten books, and many articles in peer-review international journals. For her educational and research activities she has been awarded the 2021 Natural Resources International Legal Specialist Award from the Centre of International Sustainable Development Law.

Professor Gavouneli has also coordinated and taken part in major research teams funded by European and Greek resources, having received multiple research grants. He has published five monographs, on the principle of mutual recognition in the internal market (in French, Bruylant/Sakkoulas, 1999), on domain names (in Greek, Nomiki Vivliothiki, 2001, with V. Tountopoulos), on the doctrine of essential facilities under EU competition law (in Greek, Sakkoulas, 2002), on the regulation of services in the EU (in English, OUP, 2012) and on the collaborative economy and EU law (in English, Hart, 2018). He has also published over a hundred articles and case notes, in English, French and Greek. He has a longstanding experience as a lawyer, practicing before the highest national courts and the Court of Justice of the EU.

Noora Lori is an Assistant Professor of International Relations at the Pardee School of Global Studies, Boston University. Her research focuses on citizenship, migration and racial politics in the Middle East and in comparative perspective. Her book, Offshore Citizens: Permanent "Temporary" Status in the Gulf (Cambridge University Press 2019) received the best book prize from the Migration and Citizenship section of the American Political Science Association (2020), the Distinguished Book Award from the Ethnicity, Nationalism, and Migration Studies section of the International Studies Association (2021), the Best Book in from the Middle East and North Africa politics section of the American Political Science Association. She has published in the International Migration Review, International Journal of Middle East Studies and Journal of Global Security Studies, among other journals and edited volumes. Her work has been funded by the ACLS/Mellon foundation, Ziet-Stiftung Ebelin und Gerd Bucerius, the Hariri Institute for Computing and Computer Engineering (BU), the Initiative on Cities (BU) (2016; 2019), as well as other grants. She is the codirector (with Kaija Schilde) of the Pardee School Initiative on Forced Migration and Human Trafficking. She was previously an Academy Scholar at the Harvard Academy for International and Area Studies, a fellow at the International Security Program of the Harvard Kennedy School, and a visiting scholar at the Dubai School of Government. 

Negin Torfinezhadian was born in South Iran. She arrived in Lesvos, Greece 7 years ago on the day that she turned 18 years old, seeking asylum with well-founded fear of persecution being a victim of forced marriage. Her journey to Greece has been quite challenging as she had to walk during the biggest part of her journey. Mrs. Torfinezhadian experienced staying in the refugee camp of Moria in Lesvos and resided in Elaionas camp in Athens. Despite the significant challenges of being a young refugee and a single mother, Mrs. Torfinezhadian has been supporting other refugees either by working as a volunteer or as a paid interpreter since her arrival in Greece and onwards. This significant experience led her to her current role working as a mentor for UAMs in the Special Secretariat for the Protection of Unaccompanied Minors in the Ministry of Migration and Asylum providing guidance through her lived experience to unaccompanied children residing now in Greece.

Khatharya Um is Associate Dean and Associate Professor in the Department of Ethnic Studies at the University of California, Berkeley where she also received her PhD in Political Science and was the Chancellor's Distinguished Postdoctoral Fellow. Professor Um is Co-founder of the Critical Refugee Studies Collective and former Chair of the IARU Global Transformation Working Group. Dr. Um's scholarship centers on Southeast Asia, diaspora studies, and critical refugee studies, postcolonial, and peace and conflict studies. Her scholarship has informed refugee policies and programs in the US and internationally. An impassioned community advocate, she has also co-founded and served on the board of numerous refugee-led and refugee-serving organizations. The Greek National Commission for Human Rights (GNCHR) is the independent advisory body to the Greek State (in accordance with the UN Paris Principles) and the national institution for the protection and promotion of human rights (NHRI) in Greece.

Mission

-The constant monitoring of developments regarding human rights protection, the continuous briefing and promotion of the relevant research.

-The maintenance of permanent contacts and co-operation with international organizations, such as the United Nations Organisation, the Council of Europe, the OSCE, with National Human Rights Institutions of other States, as well as with national or international non-governmental organisations.

-The formulation of policy advice of human rights issues.

Impact

The GNCHR plays an important and constructive role in the effective implementation of human rights protection, constantly monitoring developments related to the human rights situation in Greece and abroad and the implementation of human rights law, providing ongoing advisory to the competent bodies of the State. Its advisory role, however, is not limited to submitting opinions, recommendations, proposals or reports and participating in Parliamentary sessions but also extends to assisting the reports submitted by national competent authorities for their compliance with international, regional and / or and European human rights standards (reporting) as well as encouraging the ratification of international human rights treaties.

Impact

THP currently operates 13 shelters in Athens, overseen by the Child Protection Unit. THP has supported over 1,000 children since 2016, successfully reuniting 225 of them with their families throughout Europe and has created 220 jobs. Notably, THP employs 25 individuals who were formerly beneficiaries of its shelters, serving as caregivers, interpreters, and cleaners.

Education holds a crucial position in THP's approach, as all children under their care attend Greek schools. The organization has formed partnerships with three renowned private educational institutions, which have played a vital role by offering scholarships enabling children to pursue higher education at the college and university level in Greece and in the US.

In Greece, care for unaccompanied refugee children remains scattered among NGOs and international bodies. Available European Union funds for accommodation and social welfare services remain under-utilized. The Greek state needs to develop the requisite capacity to properly protect and integrate refugee children who arrive alone. Chronic institutional incompetence contributes to social discontent and fatigue with refugee issues, giving ground to xenophobia and racism in public discourse and politics. There are 2,219 unaccompanied children in Greece today. A large number of them are excluded from institutional child protection services, without access to basic care, social welfare, or any information about their rights.

<u>Mission</u>

The HOME Project (THP) is a nonprofit organization created in 2016 to care for unaccompanied children whose families and lives are wrecked by war and persecution, empowering them to persevere and grow into active citizens.

What we do

We aim to improve the lives of unaccompanied minors by influencing child protection policy at a national and international level. Our goal is to influence society as a whole by guiding refugee children to become active citizens and encouraging local communities to welcome them.

At the heart of the organization is the THP child protection model, which provides:

1. A holistic network of child protection services guided by an Individual Development Plan addressing each child's particular needs over time, including physical and mental health, education, life skills, social and legal support

2.Employment for Greeks, migrants and refugees, including children reaching adulthood

3.A healing and inclusive environment, and active engagement of the local community in order to cultivate social inclusion

Impact

MSF is currently active in several locations across Greece:

In **downtown Athens**, MSF runs an Urban Day Care Center and a Clinic to respond to the medical needs of asylum seekers/migrants residing all around the city.

The Victoria Square Clinic provides primary healthcare and mental healthcare during afternoon and evening hours. Moreover, at a third center MSF and partner organization provide medical and mental healthcare to **survivors of torture and violence**. Médecins Sans Frontières (MSF) was founded in 1971 in France by a group of doctors and journalists in the wake of war and famine in Biafra, Nigeria. Their aim was to establish an independent organisation that focuses on delivering emergency medicine aid quickly, effectively and impartially.

<u>Mission</u>

We provide medical assistance to people affected by conflict, epidemics, disasters, or exclusion from healthcare. Our teams are made up of tens of thousands of health professionals, logistic and administrative staff - bound together by our charter. Our actions are guided by medical ethics and the principles of impartiality, independence and neutrality. MSF was created in the belief that all people should have access to healthcare regardless of gender, race, religion, creed or political affiliation, and that people's medical needs outweigh respect for national boundaries.

Impact (Continue)

In the **Elliniko** camps MSF teams provide sexual and reproductive healthcare, mental healthcare, distribute hygiene kits, and conduct health promotion activities.

In the camp of **Thermopyles** MSF provides mental healthcare and sexual and reproductive healthcare.

In **Lesvos**, MSF runs a Clinic in the town of Mytilini for all asylum seekers and migrants residing on the island.

In the camps of **Malakasa, Lavrio and Ritsona** MSF provides mental healthcare to migrants and asylum seekers

Legal support

European Lawyers in Lesvos (ELIL) provides free, independent legal assistance to refugees in Greece and Poland

Mission

The asylum process is a legal one, yet in Greece there is no state-provided legal aid available for asylum seekers before their decisive first interview, meaning that most attend without having spoken to a lawyer. The only way an asylum seeker can receive legal assistance at this stage is through one of the NGOs in Greece.

We familiarise asylum seekers with the asylum process and criteria, help them understand their rights and obligations and be fully prepared for their interview. Our work contributes to upholding the rule of law, protecting human rights and ensuring the asylum procedure is fair, efficient and robust.

Impact

ELIL believes that every refugee should be able to receive assistance from an independent, experienced lawyer. Of those we have assisted in Greece, 70.8% have been granted asylum, compared to an average of 30% nationally.

Through complete suggestions and targeted actions, we pursue to give answers to problems that our fellow citizens, that live as outsiders, have to deal with and that experience social exclusion, with the goal for them to become selfdependent and self-reliant. We become their voice, when it's needed, claiming rights that should be self-evident for every human being. We come across two types of people on the streets: Street Connected Adults (homeless, unemployed that live below the poverty line, people who use drugs, immigrants, refugees, human trafficking victims, sex workers). Street Connected Children (unaccompanied minors, working children, human trafficking victims).

<u>Mission</u>

Our mission is to approach street connected people, while at the same time giving them access to food, counseling, entertainment, first aid, clothing and personal hygiene. Our next goal is to provide space in apartments, in order for them to gain privacy. Our final goal is to provide them with the opportunity to develop their skills and/or to be trained in order for them to be autonomous.

Tastes of DamascusSocial restaurantRefugee Entrepreneurship

Tastes of Damascus, Zaatar NGO's latest project, is an eco-friendly restaurant serving healthy vegetarian Middle Eastern cuisine and offering training and job opportunities to asylum-seekers and refugees.

Mission

Mutual integration: Integration works both ways.

Since Greece is not a very diverse country, we believe that our project has a great impact on breaking barriers.

A long-term goal of our project is therefore to open minds and widen horizons, making Greek people more curious of foreign cultures and others.

We aim at promoting the Syrian culture while changing locals' conceptions of refugees as a weight for society, demonstrating how they instead can bring new flavours and experiences to the city.


Impact

So far, Za'atar NGO has trained four groups of ten refugees and asylum-seekers (total of 40 students) in the basic skills required to work in the restaurant industry in Greece. The Restaurant Training Course took place at our day-center organization, the Orange House, and are taught in Greek, which greatly improves their chances of getting a job in after graduating from the training. The Restaurant Training Course is taught by a woman from Syria, who also is the full-time manager at Tastes of Damascus. Our students receive basic training in making all the most common dishes in both Greek and Middle Eastern cuisine.

After completing the Restaurant Training Course, students are given the opportunity to apply to work at Tastes of Damascus, where we support them with our team to complete the paperwork that is required to hire them. Employees receive a standard salary while being trained to improve their cooking skills and their knowledge of the Greek language. The goal is that after few months, employees/students will be able to go work in another restaurant and maintain their job, allowing us to welcome more students to be trained.


